### **VERIFICATION OF LTIFR DATA SUBMITTED**

Lost-time injuries frequency rate (LTIFR): Any work-related injury that results in the company employee or third-party contract employees not being able to return to work the next scheduled day/shift.

LTIFR is the number of lost time injuries per million hours worked, calculated using the formula. LTIFR = (Number of lost time injuries)/ (Total hours worked in accounting period) \*1,000,000.
